

Privacy Policy

Policy Introduction

This privacy policy sets out how Fleetmaster Operational Support Services Ltd collect, stores, processes and protects personal data that you provide Fleetmaster Operational Support Services Ltd when you use the licence checking service.

Fleetmaster Operational Support Services Ltd prioritises data privacy and adheres strictly to GDPR regulations to ensure that your privacy is protected. Fleetmaster Operational Support Services Ltd may ask you to provide certain personal data by which you can be identified and to support the administering of accounts and the licence checking service provided.

This policy is effective from the 10th September 2025 and may change from time to time so it is advised that you revisit this policy from time to time to ensure you are happy with any changes made.

Collecting Personal Information

All information provided is supplied voluntarily and only information required for the administration of the licence checking service will be collected. Before any request is made to access driving licence data, clear and informed consent shall be obtained by all individuals.

Any questions not suitably answered, may result in your licence check not being processed and verified by DVLA.

We may collect the following information:

- Name and full postal address.
- Contact information including email address.
- Other information relevant to your application.

If any information requested within the e-declaration is not provided or complete, the check may be rejected.

Using Your Personal Information

The information provided is used to access information held on the DVLA's Access to Driver Data (ADD) service only.

Your data is shared with your employer and any other companies named in the e-declaration process. The data is used primarily to verify your legal entitlement to drive whilst in their employment. But may also be used in relation to other road risk related products/services as defined by your employer.

Security

All information you provide to us is stored on hosted secure servers.
